

Senior housing project advances

Ground breaking set for Monday

FISHKILL — Affordable senior housing in the Town of Fishkill is one step closer to becoming a realty.

A ground-breaking ceremony will be held Monday on Dogwood Lane to celebrate Fishkill's first endeavor into affordable housing for seniors.

"Horizons at Fishkill," a 90-unit complex, is being developed by Regan Development Corp., which is based in Ardsley, Westchester County.

The complex, scheduled to open in December 2005, will feature one-bedroom apartments with monthly rents of \$790 and two-bedroom apartments for \$944. Applications are available.

Amenities include a community activity room, library, exercise room, tenant gardening areas, covered parking, on-floor laundry facilities and a computer room.

Larry Regan, president of Regan Development Corp., described the complex as a "win-win situation" for the town, residents and his company.

"Seniors, ages 55 and up, are such a strong demographic for affordable housing," he said. His familyowned business has devel-

oped more than 1,400 units and more than \$120 million of housing throughout New Jersey, New York and Connecticut.

The company's previous project in Dutchess' Country was done in the mid-1990s, when it worked with Hudson River Housing and built 10 houses on vacant lots in the City of Pough-kenysie

When Regan approached Fishkill town Supervisor Joan Pagones with a proposal everything came together. The town planning board gave final approval in April.

State financing

The affordable rents are possible through more than \$5.8 million in State of New York Housing Finance Agency bond financing, as well as federal tax credit financing, the company said. Also, the state agency is providing special low-interest financing and the town has provided tax incentives.

To help lower construction costs, Key Bank is providing a letter of credit for \$8.2 million, and Alliant Capital of Woodland Hills, Calir, is providing equity investment to help keep debt down, allowing for lower rents.
